

MINUTES OF REGULAR COUNCIL MEETING HELD JANUARY 2, 1979

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

MOTION WAS MADE BY REED AND SECONDED BY WADE THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD DECEMBER 19, 1978, BE AMENDED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY ALLEN AND SECONDED BY REED THAT THE LIBRARY'S CASH BALANCE BE TURNED OVER TO THE LIBRARY. MOTION CARRIED.

MOTION WAS MADE BY ALLEN AND SECONDED BY BANKSON THAT 8-2 YARD TRASH CONTAINERS AT A COST OF 225.00 EACH AND 4-1 1/2 YARD TRASH CONTAINERS AT A COST OF 191.00 EACH BE PURCHASED FROM THE REVENUE SHARING FUND. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY PIERCEFIELD THAT A PIPE CUTTER BE PURCHASED FROM VICTOR L. PHILLIPS IN THE AMOUNT OF 375.00 FROM THE WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY PIERCEFIELD AND SECONDED BY WADE THAT THE ORDINANCE ON NUDITY BE PRESENTED AT THE NEXT COUNCIL MEETING. MOTION CARRIED.

MOTION WAS MADE BY PIERCEFIELD AND SECONDED BY WADE THAT THE CITY PAY THE EMPLOYEE'S DEPENDENT INSURANCE BEGINNING JANUARY 1, 1979. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY HOPKINS THAT PAYROLL ORDINANCE 78-28 IN THE AMOUNT OF 5,632.03 AND PAYROLL ORDINANCE 79-1 IN THE AMOUNT OF 5,313.93 AND CDBG ORDINANCE 78-24 (REVISED) IN THE AMOUNT OF 46,533.97 AND CDBG ORDINANCE 79-1 IN THE AMOUNT OF 121,418.74 BE APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY HOPKINS AND SECONDED BY WADE THAT THE CITY TAKE THE MOTOR OUT OF THE OLD RED DOG TRUCK AND PUT IT IN THE OLD CEMETERY TRUCK TO BE USED AS A STOCK MARSHALL TRUCK AND THAT BIDS BE TAKEN ON A THREE QUARTER TON PICK-UP FOR THE CEMETERY. MOTION CARRIED.
