MOTION WAS MADE BY REED AND SECONDED BY HOPKINS THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD DECEMBER 20, 1977 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT THE POLICE REPORT FOR DECEMBER IN THE AMOUNT OF \$816.00 AND THE STOCK MARSHALS REPORT IN THE AMOUNT OF \$6.00 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY HOPKINS THAT STREET REPAIRS BE CONTINUED WEATHER PERMITTING AND STREET COMMITTEE BRING RECOMMENDATIONS TO THE COUNCIL. MOTION CARRIED.

MAYOR MURRAY PRESENTED TO THE COUNCIL A LETTER OF RESIGNATION FROM CITY CLERK JACK LA TURNER TO BE EFFECTIVE JANUARY 17, 1978.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HOPKINS THAT THE RESIGNATION BE ACCEPTED. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY DAVIES THAT THE CITY ADVERTISE IN LOCAL NEWSPAPER TO ACCEPT APPLICATIONS FOR ASSISTANT CITY CLERK AND JUANITA SCOTT ASSUME DUTIES OF CITY CLERK. MOTION CARRIED.

MAYOR MURRAY INSTRUCTED CITY ATTORNEY TO DRAFT A LETTER TO DOYLE'S OFFICE MACHINES INC. AND ADVISE HIM THAT IF NEW BILLING MACHINE PURCHASED BY THE CITY IS NOT IN OPERATION FOR WATER BILLING WITHIN IO DAYS OF THIS DATE THE MACHINE WILL BE RETURNED AND MONEY REFUNDED TO THE CITY.

CITY ATTORNEY PRESENTED COUNCIL WITH BIDS ON A NEW CITY MAP AND ASK FOR THEIR RECOM-MENDATION AT THE NEXT REGULAR COUNCIL MEETING.

MOTION WAS MADE BY DAVIES AND SECONDED BY HOPKINS THAT THE MEETING ADJOURN. MOTION CARRIED.
