OLD BUSINESS:

SANITATION RATE
INCREASE - ORD.#83-1:

Moved by Bankson, seconded by Little, to approve Ordinance No. 83-1, increasing sanitation rates by 25¢ (twenty-five cents) and setting new rates for Dumpsters by size and number of pick-ups. Motion declared carried.

AUXILIARY POLICE ORD.#83-2:

Moved by Means, seconded by Bankson, to approve Ordinance No. 83-2 prohibiting any Elected City Official from serving as an auxiliary policeman. Motion declared carried.

**CONDEMNATIONS:** 

Moved by Little, seconded by Bankson, to grant Jack Lee a 60-day extension on his property on East 13th. Motion declared carried.

Moved by Little, seconded by Allen, to advertise for bids for the removal and cleaning up of condemned property at 301-303 Main belonging to Fred Titus. Bids will be taken for 30 days from date of advertisement and public liability insurance will be required. Motion declared carried.

Nellie Poston's property on East 7th: Mary Giddens was present to represent Mrs. Poston. Mrs. Poston is to get a bid estimate on the repair of this property from a contractor and report back at the next meeting.

COPIER CONTRACT:

Moved by Little, seconded by R. Watkins, to renew our contract on our Minolta Copier at a cost of \$520.00 a year. Motion declared carried.

LEAGUE OF KANSAS
MUNICIPALITIES DUES:

Moved by Means, seconded by Bankson, to pay our membership dues for 1983 to the League of Kansas Municipalities in the amount of \$617.99. Motion declared carried.

POLICE CARS:

Moved by Allen, seconded by Bankson, to purchase two (2) Plymouth Grand Fury's at a cost of \$5,500 each. They are Missouri patrol cars. Motion declared carried.

Moved by Allen, seconded by Adams, to take bids for 30 days on the three (3) old patrol cars we now have. Motion declared carried.

Moved by Little, seconded by R. Watkins, to have Paul Duncan fill in and work as patrolman while Alan Wade is in Hutchinson at the police academy. Motion declared carried.
