
Moved by Watkins, seconded by Little, to approve Payroll 81-29 in the amount of \$3,356.11 . Motion declared carried. Allen abstained.

Moved by Little, seconded by Murray, to approve Payroll 82-1 in the amount of \$6,065.16 . Motion declared carried. Allen abstained.


ADJOURNMENT:
