Moved by Anderson, seconded by Byrd to approve a Cereal Malt Beverage License for the Sports Page. Roll Call vote: 4 Ayes (Anderson, Byrd, Murray & Stephenson), 4 Nays: (Hayes, WAtkins, Moody, & King). Deciding vote cast in favor by Mayor Thomas Allen. Motion declared carried.

MENGHINI STATEMENT:

Moved by Stephenson, seconded by Anderson to all the statement from Menghini & Menghini, Attorneys at Law in the amount of \$888.00 in the Mann vs. City of Galena Case. Motion declared carried.

WASTE WATER REVOLVING LOANS:

Mayor Allen announced that Rex Heap from the Kansas Department of Health would conduct an information meeting with Council Members on Friday, January 8, 1988 at 1:00 P.M. at City Hall. The meeting is to explain the new loans that may be available in Kansas when Grant Programs end withing the next two years.

COURT REPORT:

Moved by Anderson, seconded by Watkins to place on file the December Court Report with collections totaling \$689. Motion declared carried.

ANIMAL CONTROL REPORT:

Mayor Allen reviewed the Animal Control Report he received from the Animal Control Officer.

LANDFILL INSPECTION:

After reviewing the Landfill Inspection Report, Mike: King recommended that the sanitation committee meet with the Superintendent periodically and check on the condition of the landfills.

SGT PEPPERS:

City Attorney reported he had met with Sgt Peppers attorneys. The City has two options concerning the injuction Sgt Peppers filed against the City. They can request a hearing & continue with the trial or compromise. Several compromises were discussed at the attorneys meeting. He gave several examples of these compromises.
