COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT:

MOTION WAS MADE BY HOPKINS AND SECONDED BY AVICOLA THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD JANUARY 3, 1978 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE COUNCIL WITH APPLICATIONS FOR BEER LICENSES AT THE FOLLOWING BUSINESS: ELKS LODGE #677-7th & JOPLIN AND JACKS SELF SERVE-320 W. 7th

MOTION WAS MADE BY HOPKINS AND SECONDED BY AVICOLA THAT THE ABOVE APPLICATIONS BE APPROVED. MOTION CARRIED. (1)NAY

MOTION WAS MADE BY AVICOLA AND SECONDED BY WADE THAT PAYROLL ORDINANCE 78-2 IN THE AMOUNT OF \$1,821.74 BE APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA TO GIVE FRED BRAUN THE AUTHORITY TO SIGN CHECKS UNTIL FEBRUARY 7 WHEN A NEW TREASURER CAN BE APPOINTED. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HOPKINS THAT THE MEETING ADJOURN FOR TEN MINUTES UNTIL 7:15 FOR A SPECIAL COUNCIL MEETING TO DISCUSS PAY RAISE AND ALSO INSURANCE.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE TO REFUND \$802.05 TO METROPOLITAN LIFE INSURANCE BECAUSE OF A COMPUTER ERROR. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA TO PAY HARDWICK INSURANCE \$133.00 FOR INSURANCE ON THE STEAM BOILER POLICY. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA TO PAY \$1,661.00 TO HARDWICK INSURANCE FOR RADIO AND CONSTRUCTION EQUIPMENT FOR THE CITY. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE TO PAY \$5,379.00 TO HARTLEY INSURANCE FOR THE FLEET AUTOMOBILE INSURANCE. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY WADE TO GIVE 5% INCREASE OF WAGES TO EMPLOYEES AND WHEN THE CITY RECEIVES THE 1977 AUDIT ON THE CASH FLOW IF CITY IS FINANCIALLY ABLE THEY WILL PAY ALL OF EMPLOYEES INSURANCE. MOTION CARRIED.
