MOTION WAS MADE BY LEONARD AND SECONDED BY DAVIES THAT MINUTES OF REGULAR COUNCIL MEETING HELD JANUARY 4, 1977 AND SPECIAL COUNCIL MEETINGS HELD JANUARY 8 AND JANUARY 13 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT THE 3RD YEAR FUNDING APPLICATION FOR THE C.D.B.G. BE SUBMITTED. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY LEONARD TO APPROVE MARY ANN LITTLE, LOIS WARD, AND HAL LEONARD TO REPRESENT THE CITY AT THE E.D.A. MEETING IN KANSAS CITY TO BE HELD JANUARY 25 WITH ALL EXPENSE PAID. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT MARY ANN BE AUTHORIZED TO CONTACT LAB FOR TEST BORE DRILLING ON THE LAND SITE FOR THE NEW COMMUNITY BUILDING. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT THE CITY ATTORNEY START LEGAL PROCEEDINGS AGAINST MILLER HAULING SERVICE FOR BREACH OF CONTRACT TO THE CITY. MOTION FAILED.

MAYOR MURRAY APPOINTED A COMMITTEE OF AVICOLA, HANSBRAUGH, WARD, AND CITY ATTORNEY TO MEET WITH MILLER AND REPORT BACK TO THE COUNCIL AT THE FEBRUARY 1 REGULAR MEETING.

MOTION WAS MADE BY LEONARD AND SECONDED BY HANSBRAUGH THAT PAYROLL AND APPROPRIATION ORDINANCE 77-1 IN THE AMOUNT OF \$51,158.97 BE APPROVED AS AMENDED. MOTION CARRIED.
