MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE REGULAR MEETING HELD JANUARY 18 AND SPECIAL MEETING HELD JANUARY 27 BE APPROVED AS AMENDED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY LEONARD THAT THE POLICE REPORT FOR JANUARY IN THE AMOUNT OF \$1,100.00 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY HANS BRAUGH AND SECONDED BY BANKSON THAT THE POLICE CAR BRAKES BE REPAIRED AT A COST OF \$54.12. MOTION CARRIED.

MOTION WAS MADE BY BOGLE AND SECONDED BY AVICOLA TO PURCHASE 55 GALLONS OF VEGETATION CONTROL W/24D AT A COST OF \$481.25 FOR THE CEMETARY. MOTION CARRIED.

COUNCILMAN DAVIES MADE A REPORT THAT THE PURCHASE ORDER SYSTEM IS NOT BEING USED BY SOME CITY OFFICIALS AND ARE AKING FOR A PURCHASE ORDER AFTER ITEM HAS BEEN AQUIRED.

MOTION WAS MADE BY BOGLE AND SECONDED BY AVICOLA THAT (3) LAWN BOY 21" MOWERS BE PURCHASED AT A COST OF \$465.00 FOR THE CEMETARY. MOTION CARRIED.

MAYOR MURRAY APPOINTED A COMMITTEE OF SAM LANDIS, CHARLES HAMPSON, ROBERT JONES, ROY HOPKINS, PAUL AVICOLA TO MEET WITH THE COUNTY COMMISSIONERS CONCERNING THE REPAIRS OF FLOOD DAMAGE TO THE BRIDGE AND SIDE WALKS ON NORTH MAIN STREET.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HOPKINS TO ADJUST WATER BILLS FOR PERSONS LETTING THEIR WATER RUN TO PREVENT FROZEN WATER LINES FOR THE MONTH OF JANUARY. MOTION CARRIED.

MOTION WAS MADE BY LEONARD AND SECONDED BY HANSBRAUGH THAT THE CITY EMPLOYEES BE GIVEN A 10% WAGE INCREASE, AND THE CITY ATTORNEY DRAFT AN ORDINANCE FOR THE WAGE INCREASE. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BANKSON THAT THE CITY ADVERTISE FOR APPLICATIONS FOR PARK CARETAKER IN THE LOCAL NEWSPAPERS. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT THE CITY ATTORNEY DRAFT AN ORDINANCE THAT WILL PROHIBIT ANDY AMEMBER OF AN ELECTED OFFICE TO BE A MEMBER OF THE AUXILLARY POLICE. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HANSBRAUGH THAT PAYROLL ORDINANCE 77-2 IN THE AMOUNT OF \$4,276.36 AND C.D.B.G. ORDINANCE 77-3 IN THE AMOUNT OF \$6,496.81 BE APPROVED FOR PAYMENT. MOTION CARRIED.
