

MINUTES OF  
GALENA CITY COUNCIL MEETING  
FEBRUARY 15, 1983

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order by President of Council Donald Means, at 7:00 P.M., in the Council Chambers on Tuesday, February 15, 1983.

ROLL CALL:

Roll Call indicated the following councilmembers present: Adams, Hayes, Means, Little, J. Watkins (came in after roll call), Bankson, Allen, R. Watkins, Absent: Shallenburger, Murray.

MINUTES:

Moved by Bankson, seconded by Little, to approve and place on file the minutes of the Regular Meeting on February 1, 1983. Motion declared carried.

CONDEMNATION -  
FRED TITUS:

Moved by Adams, seconded by Hayes, to grant an additional 60 day extension to Fred Titus to bring his building at 301-303 Main up to code. The building must be completed at the end of the 60 days. Motion declared carried.

The bids that were to be opened for the demolition of 301-303 Main are to be held the 60 days and be opened then if the building is not completed. The City Clerk is to notify the contractors to see if they want their bids held.

ROSENBERRY- TRAILER  
PERMIT

Mrs. Foster Rosenberry appeared before the council to request the placement of a mobile home. The council informed her that the Planning and Zoning would have to handle the application and determine if it could be rezoned for agriculture or not. City Clerk is to notify Doyle Castleberry and see how fast this can be done.

RAISES:

Moved by Allen, seconded by Bankson, to have an ordinance drafted to reflect the proposed raises submitted by the Finance Committee. Roll call vote indicated:

MEALS - ELECTION  
WORKERS:

Moved by Little, seconded by J. Watkins, to furnish 25 election workers with a noon meal for the Primary Election not to exceed \$2.25 each. Motion declared carried.

GALENA DAYS:

Moved by Bankson, seconded by R. Watkins, to grant permission to the Fire Department to block between 6th & 7th on Short Street and 6th & Main to Short during May 30,31, June 1-4 for the Carnival for Galena Days. Also let them use the Front of the City Hall for activites, use community room for dinners, block off Main from 4th to part of 7th from 6:00 to 3:00 on Saturday for the Flea Market, block off Main for the Parade on Saturday afternoon. Grant permission for the Fire Dept. to build a sidewalk from the east fence to the parking lot in front of City Hall with the Fire Dept. furnishing both labor and material. Motion declared carried.

CITY CLERK SCHOOL:

Moved by Little, seconded by Bankson, to allow Barbara Wilkins to attend City Clerk School in Lawrence on March 16-18 at a cost of around \$200. Motion declared carried.

VACATIONS:

Moved by J. Watkins, seconded by Hayes, to approve one (1) weeks pay in lieu of vacation for Winnie Burkhart. Motion declared carried.

DOG CLINIC:

Moved by J. Watkins, seconded by Adams, to let Dr. Wolf from Riverton handle the dog clinic this year. The time will be Friday, May 6 from 4:00 to 5:00 P.M. and May 7, from 1:00 to 5:00 P.M. Motion declared carried.

ENTERPRISE ZONE WORKSHOP:

Moved by Little, seconded by Bankson, to allow the City Clerk to attend a workshop on the Enterprise Zone in Chanute on February 23rd with gas to be furnished. Motion declared carried.

COMMITTEE REPORTS:

The Police Committee is to get together with the dog catcher to discuss some of the problems they are having and to report back to the Council the next meeting.

The Cemetery Committee is to meet with Harvey Jones, cemetery sexton, to see if he is going to retire in May.

The Chief of Police is to have a fill in patrolman to work for the regular patrolman while they take off their accumulated holidays.

Moved by J. Watkins, seconded by Adams, to approve payroll 83-4 in the amount of \$12,802.78. Motion declared carried.

APPROPRIATIONS 83-4:
