WILLIAMS MACHINE TAX:

public hearing on the tax abatement request of Williams Machine was opened. David Loiselle, Cherokee County Appraisor, was present. He gave the background on the abatement given to Williams Machine in 1987. According to information he received, it was understood by the city and Williams Machine, at any time there was an expansion by Williams Machine in the 10 year period of the abatement period, there would be an exemption on this expansion for the number of in the left original years abatement. However, the Board of Appeals will not allow abatement on items that are not itemized for them. Therefore, it is necessary for the company to apply each year. The city will also need to adopt a policy and a cost benefit analysis. He stated that if the city continues with the original plan, the Board of Tax Appeals will probably approve this. Williams Machine is requesting an exemption for the years of 1988, 1989, 1990, 1991, and 1992.

The committee provided a list of the new conditions with the packets for council members.

SWIMMING POOL SKIMMERS:

The council asked to review the cost for the repair of the skimmers before making a decision on the replacement of the lights.

Chief Collins stated that the police department is in violation of the fire code. He stated the construction was originally began to get the computer out of the view of the public along with the wanted posters. It is required also that all files be kept in a locked case. They were preparing the office area for the receipt of \$17,000 in equipment which is being donated. The office would not accomodate the equipment. They were in the process of making these changes when the spending cut was put in place.

The use of the VIN fund was discussed and whether these funds were a part of the police department budget.

Mayor Watkins requested Allen to return any records he had to the police department.
