**DONATION OF PROPERTY
5th & MAIN STREET:**

Kathy Anderson representing the Chamber of Commerce addressed the commission concerning property to be donated to the city by two individuals to create a park and the city maintain it like any of the other city

is donating the property under the stipulation (to be recorded) that if any time the city no

longer wishes to maintain it as a park it will revert back to the estate of the original donor. The chamber was requesting city approval to go ahead with the park. She stated the property was located between 5th & 6th Street on the west side of the road. The park will consist of a monument area, flag area, benches, and flowers.

Motion made by Oglesby, seconded by Webster, for the acceptance of the property and the city to maintain it once its completed. Motion declared carried.

ROLL CALL:


