SENIOR CITIZENS VEHICLES:

Raymond Carlisle of the Senior Citizens Board requested the council add the Senior Citizens vehicle to the City's Insurance policy and the Senior Citizens pay the premium if it would result in a savings on the premium.

Moved by King, seconded by Watkins to request a quote from the City's insurance agent on adding the vehicle to the City's fleet policy. Motion declared carried.

CDBG ECONOMIC DEVELOPMENT GRANT HEARING:
