The Regular Meeting of the City Council of the City of Galena was called to order by Mayor James Bankson at 7:00 P.M., in the Council Chambers, on Tuesday, March 6, 1984.

Roll call indicated the following councilmembers present: King, Hayes, Little, Colgrove, Allen, Means, R. Watkins. (R. Watkins entered after roll call) Absent: J. Watkins, Gibson, Anderson.

Moved by Little, seconded by Colgrove, to approve and place on file the minutes of the Regular Meeting on February 21, 1984. Motion declared carried.

Discussion was held on the status on Kaehler's Pond. It was decided that it would be easier to re-route the drain than to fill it in. City Attorney John Fink is to write Kaehler's attorney to advise that the City will proceed with abatement of nuisance when the dozer is available.

Tom Allen presented a report from the Cemetery Association's meeting of March 5, 1984. He stated that the Cemetery Association had agreed to Bond their Treasurer and Secretary. The Cemetery Association had made the standing Cemetery Committee of the City Council, Trustees in the Association. Also, to allow 25% of their net interest to be used for the maintenance of the cemeteries. The Cemetery Association would like to set up an Independent Perpetual Care Fund for Hillcrest Cemetery.

Roll call vote indicated the following: YEAS - 5 - King, Hayes, Means, Anderson, Allen. NAYS - 3 - Colgrove, R. Watkins, Little. ABSENT - 2 - J. Watkins, Gibson.

Motion declared carried.

Moved by Means, seconded by Allen, to allow an ordinance to be drawn up authorizing the Cemetery Association to collect money at Hillcrest Cemetery... Motion declared carried. (2 Nays - Little, R. Watkins.)

Moved by Little, seconded by R. Watkins, to issue a sewer permit for an extension to the sewer line that now runs to Bob Murray's property at 22nd & Wood, with Howard Jarvis to make an inspection. Motion declared carried. (2 Nays - Means, Allen)

Moved by Little, seconded by R. Watkins, to allow Rex Gandy, Doug Pittman, and Sidney Mathews to go to water school on April 5th in Fort Scott, with the fee to be \$20.00 each and the City to furnish gas expense. Motion declared carried. Page Two
