MINUTES OF REGULAR Council Meeting TUESDAY, MARCH 15, 1988

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order Tuesday, March 15, 1988 at 7:00 P.M. in the Council Chambers with Thomas Y. Allen, Mayor, presiding.

ROLL CALL:

MINUTES:

Moved by Anderson, seconded by Hayes to approve and place on file the minutes of the Regular Meeting of March 1, 1988. Motion declared carried.

Moved by Watkins, seconded by Poelma to approve and place on file the minutes of the Special Meeting of March 8, 1988. Motion declared carried.

AMERICAN LEAGUE BASEBALL:

John Fink, representing the American Legion Baseball Association requested a donation for the team.

Moved by Byrd, seconded by Anderson to install the proper tracking and equipment to rehang the drapes. Motion declared carried.

Moved by Fitzer, seconded by Stephenson to allow \$2.50 per worker for meals on election day. Motion declared carried.

Moved by Moody, seconded by Poelma to instruct the City Clerk to notify the Alternate Water Supply Committee that the City does not wish to have a representative on the steering committee at this time and thanking them for the invitation. Motion declared carried.

Moved by Poelma, seconded by Anderson to approve and place on file the December, Year End and January Water reports. Motion declared carried.
