Moved by Shallenburger, seconded by Coleman to donate \$250.00 to the GHS After Prom Party. Motion declared carried.

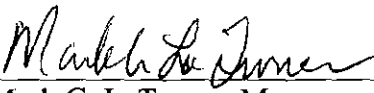
APPR# 98-3:
