

**MINUTES OF
CITY COMMISSIONERS
MEETING
MARCH 19, 2001**

CALL TO ORDER:

The meeting of the Galena City Commission was called to order on Monday, March 19, 2001, at 6:00 P.M. in the commission chambers with Mayor George Jackson presiding.

ROLL CALL:

MINUTES:

Motion made by Webster, seconded by Brandenburg to approve and place on file the minutes of the regular commission meeting March 5, 2001. **Motion declared carried.**

Motion made by Webster, seconded by Brandenburg to place on file the minutes of the Galena Fire Department Meeting of March 8, 2001. **Motion declared carried.**

CITY PARK 5th & MAIN ST.:

John Meyer representing the Chamber of Commerce addressed The commission about paying for the material for new sidewalks and curbing for the park site with the Chamber providing the labor. Estimated cost for the material would be \$3,000.00. He stated they would need 175 ft. of sidewalk and curbing on the east side and 125 ft of sidewalk and curbing on the north side.

The commission commended the Chamber on all the work they do for the city.

Commissioner Oglesby asked if there was a plan from where the money could be allocated. The City Manager stated he felt they could take it from the street fund and would check.

Moved by Oglesby, seconded by Brandenburg if there is a plan from where the funds can be allocated, that this be approved. **Motion declared carried.**

COME SURF THE NET:

City Manager, Jack Murray stated he had proposals from Come Surf the Net to network computers and Internet service. City clerk's office would be \$ 1605.00. The police department would be \$5,002.00. No action was taken.

FUND ACCOUNTING SYSTEM: City Manager, Jack Murray advised the commission we had requested Govermentor to give us a proposal on upgrading the accounting system in City Hall, which is 10 to 15 years old.


Commissioner Oglesby stated we made a motion and passed it at a previous meeting that we break the law and he would move that we undo that.
