

MINUTES OF REGULAR COUNCIL MEETING HELD APRIL 4, 1978.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

MOTION WAS MADE BY HOPKINS AND SECONDED BY WADE THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD MARCH 21, 1978 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT THE MINUTES OF SPECIAL COUNCIL MEETING HELD MARCH 23, 1978 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT THE POLICE JUDGE REPORT IN THE AMOUNT OF \$704.00 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT CHIEF AYERS BE GRANTED \$25.00 FOR EXPENSES TO GO TO A LAW ENFORCEMENT PROGRAM APRIL 13-14. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE TO PURCHASE SUMMER UNIFORMS FOR OFFICER DAN WEBB AT APPROXIMATELY \$190.00. MOTION CARRIED. (1)ABSTAINED ALLEN

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT IF HARVEY JONES SEES ANYONE PUTTING PERMANENT FIXTURES IN THE CEMETARY THAT HE BE ALLOWED TO STOP THEM AND TO CONTACT THE CITY ATTORNEY ON THIS MATTER. MOTION CARRIED.

MOTION WAS MADE BY HOPKINS AND SECONDED BY WADE THAT \$100.00 BE GIVEN TO THE SCHOOL BOY PATROL TO BE PAID OUT OF WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT C.D.B.G. ORDINANCE 78-7 IN THE AMOUNT OF \$9,199.93 AND PAYROLL ORDINANCE 78-7 IN THE AMOUNT OF \$6,623.08 BE APPROVED FOR PAYMENT. MOTION CARRIED. (1) ABSTAINED ALIEN
