Moved by Little, seconded by R. Watkins, to place on file the minutes of the Regular Meeting of the Planning and Zoning on April 9, 1984. Motion declared carried.(1 nay Anderson)

JUNK VEHICLE:

Mrs. Combs appeared before the council again to request that a vehicle that had been previously removed be returned to the residence for her sons therapy. No action was taken.

CONDEMNATIONS:

Moved by Little, seconded by Colgrove, to approve Res. 84-6 condemning property located at 719 Chicago, owned by FDIC, and giving them 30 days to remove the structure or the city will remove under the HUD Demo grant. Motion declared carried.

Moved by Colgrove, seconded by Anderson, to approve Res. 84-7 condemning property located at 1003 E. 11th, owned by American National Bank and giving 0 days to remove since the Bank had signed a removal permit. City will remove under the HUD Demo grant. Motion declared carried.

Larry Prauser, attorney for Clarence Wald, appeared before the council during the show cause hearing on property located at 218 Main. Mr. Wald wants to bring the property up to code.

Moved by Colgrove, seconded by R. Watkins, to approve Res. 84-8 condemning property located at 218 Main, owned by Clarence Wald, and giving him 90 days to bring the structure up to code or the building will be removed. Motion declared carried. Demolition permit will be reinstated immediately.

CALL TO ORDER:

<u>HUD GRANT –</u> BOOKER/FREUND ASSOC: Carl Haas with Booker/Freund Assoc. discussed a proposed water project that would correct our water loss and also solve a water volume problem on East 21st. The project does not seem to be one that would be funded on the HUD CDBG Grant. He said he could file a pre application with Farmers Home for a low interest loan at no cost to the City at this point.

Moved by Little, seconded by Colgrove to allow Carl Haas to pursue filing a pre application for a Farmers Home loan. Motion declared carried. (1 nay - Allen)

Moved by Little, seconded by Colgrove, to have the city clerk apply for additional Rehabilitation on the 1984 CDBG Grant in accordance with the same guidelines used for the 1983 rehab. Motion declared carried. (1 nay - Anderson)

CEMETERY:

Moved by Allen, seconded by King, to get estimates on spray for the trees and shrubs at the cemetery. Motion declared carried.

CEMETERY HELP:

Moved by Colgrove, seconded by Little, to hire 4 employees for the last 2 weeks in May, to help cut the cemeteries for Memorial Day at minimum wage. Motion declared carried.

CEMETERY MAPS:

Moved by Colgrove, seconded by R. Watkins, to allow Tom Wade to get new maps made for the three Cemeteries at a cost of approximately \$30 for each original film. Motion declared carried.

SPECIAL TRASH PICK-UP:

Moved by Allen, seconded by Colgrove, to approve a Spring Trash Pick-Up and advertise it for May 5 and 12th. Motion declared carried.

Moved by Little, seconded by R. Watkins, that the words "and a current motor vehicle safety inspection certificate" in section 2 (c) be deleted and then approved Ord. #84-5 relating to abandoned, wrecked, junked vehicles. Motion declared carried.

CRIMINAL DAMAGE
ORD. # 84-6:

Moved by Little, seconded by R. Watkins, to approve 0rd. # 84-6 defining criminal damage to property and providing for the penalty. Motion declared carried.

CRIMINAL TRESPASS ORD. # 84-7:

Moved by R. Watkins, seconded by Little, to approve Ord. #84-7 defining criminal trespass and providing for the penalty. Motion declared carried.

OFFICERS TRAINING SCHOOL:

Moved by Little, seconded by King, to send 6 police officers to MSSC on April 25 at a cost of \$10 each and 5 officers on May 8-9 at a cost of \$15 each for training school. Motion declared carried.

Moved by Colgrove, seconded by R. Watkins, to send Chief of Police, Lyerla, to Wichita to KACP Meeting April 19-20 at a cost of \$145. Motion declared carried.

TELEPHONE CONTRACT:

Moved by Anderson, seconded by King, to enter into an emergency service contract with Contel Telephone Company for our 911 number. Motion declared carried.

GALENA DAYS:

Moved by R. Watkins, seconded by Allen, to allow Cherokee County Coalition to use the council room to show a film on stress and child abuse during the Galena Day celebration. Motion declared carried.

Moved by Colgrove, seconded by R. Watkins, that the second half of the Regular Meeting of the City Council adjourn. Motion declared carrried.
