INDUSTRIAL PARK:

Moved by Colgrove, seconded by R. Watkins, for the City to enter into negotiations with Williams Machine & Tool Co., Inc. for the 3 acre tract next to Zodiac with the stipulation that the building must be at least 60' X 72'. The lease would be for 1 year and would be sold at the end of the 1 year for \$1.00, pending the building of the structure. Motion declared carried.
