MINUTES OF GALENA CITY COUNCIL MEETING MAY 3, 1983

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order by Mayor James Bankson, at 7:00 P.M., in the Council Chambers on Tuesday, May 3, 1983.

ROLL CALL:

MINUTES:

Moved by Little, seconded by J. Watkins, to approve and place on file the first half of the minutes of the Regular Meeting on April 19, 1983, with Mayor Wade presiding. Motion declared carried.

Moved by J. Watkins, seconded by R. Watkins, to approve and place on file the second half of the minutes of the Regular Meeting on April 19, 1983 with Mayor Bankson presiding. Motion declared carried.

SCHOOL PROPERTY CONDEMNATION:

Bob Scott from the Galena School Board appeared before the Council to request the Council to condemn and remove the property at 608 E. 7th and bill the school board.

STOCKMARSHAL TRUCK:

BALL PARK:

Moved by Little, seconded by Hayes, to get bids on 4 all metal doors and frames for the concession stand at the new ball park. Motion declared carried.

BRASS MONKEY - BUILDING PERMIT:
