MINUTES OF REGULAR COUNCIL MEETING MAY 7, 1991

CALL TO ORDER:

The Regular Meeting of the Galena City Council was called to order Tuesday, May 7, 1991 at 7:00 p.m. in the Council Chambers with Roy Watkins, Mayor, presiding.

TRI STATE RECYCLING:

Mr. Duane Snapp, of Tri State Recycling requested council release the 1st lien on skid loaders. The city's financing statement showed a 1st lien on machinery purchased with the CDBG grant and a second lien on other machinery and equipment. Mr. Snapp explained that he had paid off a loan to Mr. Crossland and the Columbus Bank which released their finaning statements and liens on two skid loaders. This moved the city to a 1st position on these loaders. He is desiring to refinance equipment including the skid loaders with Ford Motor Credit but has been delayed because of the city's being in 1st position on these loaders. He requested the city release their 1st lien on the skid loaders and file a second.

The city attorney, Mr. Barrett, requested he bring the documentation to him and he would make a recommendation at the next council meeting.

Mr. Snapp also requested clarification of the zoning of the property at his recycling center and to allow a composting operation at the facility. He also requested the Mayor be authorized to sign the application for the composting license stating the zoning was proper.
