MINUTES OF MEETING HELD MAY 17, 1976.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

ALL COUNCIL MEMBERS WERE PRESENT:

MAYOR MURRAY EXCUSED HIMSELF FROM THE COUNCIL ROOM FOR THE PURPOSE OF THE NEW COUNCIL ELECTING A PRESIDENT OF COUNCIL TO FILL IN IN CASE OF ABSENCE OF MAYOR. MOTION WAS MADE BY BOGLE AND SECONDED BY AVICOLA THAT HANSBRAUGH BE PRESIDENT. MOTION WAS MADE BY MESSER AND SECONDED BY MURRAY THAT DAVIES BE PRESIDENT. MOTION WAS THEN MADE BY BANKSON AND SECONDED BY WARD THAT NOMINATIONS BE CLOSED. UPON A ROLL CALL VOTE, DAVIES WAS ELECTED FIVE TO THREE. MAYOR MURRAY RETURNED TO ROOM—— MEETING CONTINUED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT THE MINUTES OF MEETING HELD MAY 4, 1976 BE APPROVED AS AMENDED. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY MESSER TO ADVERTISE FOR APPLICATIONS FOR VACANCIES OF 1ST WARD COUNCILMAN - TWO YEAR TERM AND 4TH WARD COUNCILMAN - ONE YEAR TERM. MAYOR MURRAY APPOINTED A COMMITTEE OF DAVIES, BANKSON, AND BOGLE TO REVIEW THE APPLICATIONS RECEIVED. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BANKSON THAT THE FOLLOWING ELECTED OFFICERS OF THE GALENA LIBRARY BOARD BE APPROVED. CHAIRMAN - MRS. W.E. McCOY VICE CHAIRMAN - MRS. DAN ABBEY - TREASURER - MRS. CARL WHITTINGTON - SECRETARY BILL BRADY - MEMBERS - DORTHY SENTER, MRS. HOWARD PRICE, MR. HARRY GLADES, MRS. R.G. POWELL HAS TAKEN LEAVE OF ABSENCE BUT IS EXPECTED BACK. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BOGLE THAT THE COUNCIL CALL A TEN MINUTE EXECUTIVE SESSION TO DISCUSS REPEAL OF ORDINANCE 827. MOTION CARRIED. UPON RETURN OF PUBLIC TO ROOM, A ROLL CALL VOTE WAS TAKEN TO REPEAL ORDINANCE 827 ENDING WITH A TIE VOTE- 4 YEA - 4 OPPOSED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT A NEW ORDINANCE BE ADOPTED FOR USE OF PURCHASE ORDERS WITH THE FOLLOWING SIGNATURES: IST - CITY CLERK VERIFYING FUNDS ARE AVAILABLE 2ND - AT LEAST TWO SIGNATURES OF THE EXECUTIVE COMMITTEE MEMBERS BEFORE PURCHASE. ORDINANCE AS SUCH TO BE DRAWN UP BY CITY ATTORNEY. MOTION CARRIED.

MOTION WAS MADE BY MESSER AND SECONDED BY BOGLE THAT APPLICATION OF CLARA HARGIS BE ACCEPTED AS PARK CARETAKER AT NO SALARY, BUT BE ALLOWED TO LIVE IN PARK HOUSE WITH CITY PAYING UTILITIES. HOUSE RENT FOR SOCIAL SECURITY PURPOSES WAS SET AT \$30.00 MONTHLY. CARETAKER DUTIES ARE AS FOLLOWS: I. KEEP RESTROOMS CLEAN 2. KEEP THE GRASS CUT AND WATERED 3. TURN PARK LIGHTS ON AND OFF 4. OPEN AND CLOSE PARK GATES. MOTION CARRIED. ONE NAY VOTE CAST — AVICOLA.

MOTION WAS MADE BY DAVIES AND SECONDED BY BANKSON TO ADOPT A RESOLUTION GIVEN BY DON NOE PERTAINING TO NEW ACCOUNTING PROCEDURES, COMBINING CHECKING ACCOUNTS, PURCHASE ORDERS, RECORDS SET UP THAT CAN APPLY TO CEMETARY ROAD FUND OR NOXIOUS WEED FUND PURCHASES, DAILY CASH BALANCE ON PURCHASE PROCEDURES AS LISTED IN K.S.A. 10-1114 AND 10-1115. MOTION CARRIED.
