MINUTES OF GALENA CITY COUNCIL MEETING MAY 17, 1983

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order by Mayor James Bankson, at 7:00 P.M., in the Council Chambers on Tuesday, May 17, 1983.

ROLL CALL:

Roll Call indicated the following councilmembers present: King, R. Watkins, Gibson, Colgrove, Murray, Hayes, Allen, Means, Little. Absent: J. Watkins.

MINUTES:

Moved by Little, seconded by R. Watkins, to approve and place on file the minutes of the Regular Meeting on May 3, 1983. Motion declared carried. (Murray abstained)

KAEHLER - VACATED ALLEY:

Marvin Kaehler appeared before the Council to discuss the ordinance vacating 3 alleys and 4 streets in the Geltz 2nd and 3rd Addition. Mr. Kaehler submitted a written protest from property owners. The protest was placed on file in the City Clerk's Office.

PLANNING & ZONING - MINUTES:

Moved by Little, seconded by Murray, to place on file the minutes of the Planning & Zoning Commission's Regular Meeting of May 9, 1983. Motion declared carried.

ITEMS FOR ACTION:

Action was not taken on the re-zoning of Mr. & Mrs. John W. Williams property because property was not yet recorded in their name.

Action was not taken concerning the mobile home in the alley between Joplin & Galena Avenues since several councilmembers said the mobile home was not in the alley and City Attorney is to read Ordinance No.82-5 and see what it says concerning a vacant mobile home.

SEWER -BILL PICKERING: Moved by Little, seconded by R. Moved by R. Watkins, to have Street & Sewer Committee look into the possibility of Mr. Pickering making payments. Motion died for lack of second.

Moved by Hayes, seconded by R. Watkins, to allow Mr. Pickering to pay the \$150 charge for breaking of blacktop in payments of \$10 a month. Motion declared carried.

BIDS - DOORS FOR BALLPARK: Moved by Little, seconded by Hayes, to accept the bid from Riverton Building Supply on 4 - 12" all metal doors for \$170.00 each. Motion declared carried.

Moved by Little, seconded by Murray, to use the 4 metal doors with wood frames where needed and charge to the department using the door since the old doors
