MINUTES OF CITY COMMISSIONERS MEETING MAY 17, 2004

CALL TO ORDER:

The meeting of the Galena City Commission was called to order on Monday, May 17, 2004, at 6:00 p.m. in the commission chambers with Mayor Scott Donaldson presiding.

ROLL CALL:

Roll call indicated the following commissioners present: DONALDSON; HARDMAN; SHOEMAKER; DAVIES; OGLESBY

Oglesby entered chambers at 6:05 p.m.

RICHIE BABITT
GALENA GIRLS SOFTBALL:

Richie Babitt spoke before the commission stating that he had heard the Galena Little League wanted to petition the city to have the girls softball field. His understanding was they might be losing the little league field. He wants to find out what they can do to keep the girls softball field and run it as they always have.

Commission stated they would have to be the ones to do this and could not see it happening, for one party to take over the field, it's a City Park, not just one persons park.

GEORGE JACKSON CITIZEN'S COMMITTEE REPORT:

George Jackson spoke before the commission on behalf of the citizens group and various other people in town. It seems the city commission does not seem to be a cohesive group as he had mentioned at a previous meeting. He stated the city has a lawsuit against them and yet they have people on the commission supporting that person and they feel that commissioner should resign and leave the room immediately.

Mayor Donaldson stated he understood were he was coming from and respected his right to say everything he said, and hand out things, and do whatever he wants to from that standpoint, but he would not let this meeting get into a shouting match.

Mr. Jackson stated he did not want the meeting to get into a shouting match, and did not want the city to get negative publicity. He stated that the citizens group once again asked for Commissioner Hardman's resignation.

Mayor Donaldson announced Walter Bradshaw was chairman of the Change of Government Committee.

Mr. Bradshaw stated since the ordinances are not specific on the appointment of committee heads he would ask for a vote of confidence from the commission.

City Attorney, Kevin Cure said this was not legally required. Mayor Donaldson stated he was going to opt out of that, he had already announced him.
