

MINUTES OF

JUNE 1, 1982

CALL TO ORDER

The regular meeting of the City Council of the City of Galena was called to order by Mayor Thomas L. Wade at 7:06 P.M. in the Council Chambers on Tuesday, June 1, 1982.

Moved by Shallenburger, seconded by Murray, to approve and place on file the minutes of the Regular Meeting on May 18, 1982. Motion declared carried.

PUBLIC HEARING:
TRAILER PERMIT

Public Hearing was held to give persons who signed petition against having a mobile home placed at 104 E. 22nd a chance to tell the owner why they objected.

Moved by Shallenburger, seconded by Allen, to accept Planning & Zoning's recommendation to deny a trailer permit to Weda Donham at 104 E. 22nd. Motion declared carried. (2 Nays - Little, Bankson)

Mr. Jim Hanley with Ks. Public Employees Retirement System (KPERS) appeared before the Council to explain the retirement system. A meeting will be held at 6:30 P.M. June 15, prior to the regular council meeting to discuss the plan with city employees.

ORDINANCE NO.82-7


Moved by Bankson, seconded by Murray, to approve Ordinance No. 82-7 re-establishing the intangible tax in the City for 1982. Motion declared carried.

Moved by Little, seconded by R. Watkins, to approve Payroll Appropriations 82-12 in the amount of \$13,162.71 . Motion declared carried.


ADJOURNMENT
