CALL TO ORDER:

- (2) Need to get insurance bids on the Ambulance mal-practice, etc.
- (3) Need to contact Missouri Southern and Labette County College to see if E.M.T. training can be held in Galena as soon as possible.
- (4) Need to apply to the County for a subsidy for Galena's share of the Ambulance money.
- (5) Our City Attorney and Baxter's City Attorney need to draw up an Aid Agreement between the two cities.
- (6) Need a 911 number from the phone company.
- (7) Need to talk with the auditors and see about expanding the budget for 1981 and possible No-Fund Warrants. Also, need to include the Ambulance Service on the 1982 budget.

City Clerk is to amend Ordinance #924 or draw up a new Ordinance for Salaried Sick Leave.

Moved by Little, seconded by Shallenburger, to discontinue Bill Hamlin's salary as of May 31, 1981 so he can draw workmen's compensation until his arm is well and he can return to work. Motion declared carried. 2-Abstensions (Adams, Watkins)
