WELL # 4 PUMP:

The water committee reported URS Consulting Firm of Buffalo New York has contracted with the Corps of Engineers to see if any of the deep wells in the area allow contaminants to enter the aquifer. All four city wells will be tested. They will pull the column and pumps on each of the wells.

While the pumps are pulled, the city will be allowed to make any repairs and necessary replacements to the well.

The pump in well #4, which provides the water to the city will be pulled last. The pump in this well was installed in 1979 and has no repairs made to it. A new pump could be installed at this time if one is available. Bids were obtained from Larson in the amount of \$4575 and from Layne Western at \$6540. One of these companies will contract with URS to pull the pumps. It has not determined which company URS will contract with. If the casing or grout is bad, EPA will probably bear the cost of replacement.

Moved by TIPTON to purchase the pump from Larson MOTION WITHDRAWN

Superintendent Sills recommends a Peabody Flowaway pump replace the current pump in well #4 and the old pump be repaired to use at a spare. The Peabody which is currently in use in the well has given very good service.
