MINUTES OF CITY COMMISSIONERS MEETING JUNE 5, 2000

CALL TO ORDER:

The meeting of the Galena City Commission was called to order on Monday, June 5, 2000, at 6:00 P.M. in the commission chambers with Mayor George Jackson presiding.

ROLL CALL:

Roll call indicated the following commissioners present: JACKSON; LATURNER; BRANDENBURG; OGLESBY; WEBSTER

MINUTES:

Motion made by Oglesby, seconded by Brandenburg to approve and place on file the minutes of the **regular** commission meeting of May 15, 2000. Motion declared carried.

Motion made by Oglesby, seconded by Brandenburg to place on file the minutes of the **special** commission meeting May 22, 2000. Motion declared carried.

PUBLIC HEARING CONDEMNATION PROPERTIES:

Public Hearing was held on property at 901 Short, 115 N. Main, 718 Mineral, 1109 Chicago, 902 Dewey, 909 Wall. Representatives for 115 N. Main, 1109 Chicago, 902 Dewey, and 909 Wall attended.

Motion made by LaTurner, seconded by Oglesby to pass Resolution 00-17 for property located at 901 Short St. and proceed with condenation procedures **allowing 60 days** to make structure safe and secure. Motion declared carried.

Motion made by Oglesby, seconded by LaTurner to table resolution for 115 N. Main giving property owner time to repair and look at it at a later date. Ayes – 0; Nays; Webster; Brandenburg, Oglesby, LaTurner; Motion died for lack of vote.

Motion made by, LaTurner, seconded by Oglesby to pass Resolution 00-18 for property located at 115 N. Main St. and proceed with condemnation procedure, allowing 60 days to make structure safe and secure. Motion declared carried.

Motion made by, LaTurner, seconded by Webster to pass Resolution 00-19 for property located at 718 Mineral St. and proceed with condemnation procedure, allowing 60 days to make structure safe and secure. Motion declared carried

Motion made by, LaTurner, seconded by Webster to pass Resolution 00-20 for property located at 1109 Chicago and proceed with condemnation procedure, allowing 60 days to make structure safe and secure. Motion declared carried

Motion made by, LaTurner, seconded by Webster to pass Resolution 00-21 for property located at 902 Dewey and proceed with condemnation procedure, allowing 90 days to make structure safe and secure. Motion declared carried

City Manager stated he had spoke with the property owner at 909 Wall about putting a mural on the wall in city hall in exchange for tearing the property down that the city might be interested in doing so.

Mayor LaTurner stated trading this out made him uneasy and did not feel it professional and should proceed as with the rest of the properties. If the city wants him to do a mural then the city should contract with him, but not cloud the issues by trading. Motion made by, LaTurner, seconded by Webster to pass Resolution 00-22 for property located at 909 Wall and proceed with condemnation procedure allowing 60 days to make structure safe and secure. Motion declared carried

Bob Scott property owner at 909 Wall stated the city had property they had taken down on 11th and Galena and the mess is still standing there and then they expect them to get there property cleaned up in an allotted amount of time with the high cost of doing it.

LANDFILL DOZER: City Manager, Jack Murray stated the dozer

for the landfill was in the shop the

transmission had gone out and stated there was a bill of \$14,500.00 against the machine as of now. He stated a final bill would be

presented to the commission.

Commissioner LaTurner stated they need to appointment a committee with commissioner Webster, City Supt. Mittag, and maybe a private citizen to take a look at the problem and any future

equipment the city purchases.

TRASH TRUCK: City Manager, stated the trash truck had been taken

to the shop for repair, replaced brakes, cleaned the injectors, repaired leak in the transmission, serviced

the equipment at a cost of \$1210.00.

COMMISSION APPOINTMENTS: Mayor George Jackson stated he wanted to appoint

Tom Brandenburg commissioner of finance and assist the city manager, city clerk, and city treasurer and try to tell them were they were at with money at

any time. Appointed Commissioner Oglesby as Commissioner of Parks and Cemeteries, Commissioner Webster as Commissioner of Streets and Landfills, Commissioner LaTurner as Commissioner of Economic Development. Mayor Jackson said he wanted to reiterate that at no time that no commissioner had no authority or supervisory abilities over any of the people or employees, this is strictly in an advisory capacity to report to the commission. Mayor Jackson appointed himself temporarily as Commissioner of the Police Dept.

TRAILER IN CITY:

Commissioner LaTurner stated they had talked about trailers in the city previously and stated it was originally brought up that they would go into an authorized trailer park and wondered if this was something this commission was interested in doing.

The City Manager and City Attorney was asked to research the codes on trailers.
