MOTION WAD MADE BY DAVIES AND SECONDED BY BANKSON THAT MINUTES OF REGULAR COUNCIL MEETING HELD MAY 17 AND SPECIAL COUNCIL MEETING HELD MAY 25 AND MAY 31 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE TO PAY FIRST ESTIMATE OF \$41,400.00 TO SELL CONSTRUCTORS INC. FROM L. P. W. GRANT AND \$10,125.36 TO HIGGENBOTHAM, AND \$934.06 TO C. B. SIMMONS FROM C. D. B. G. MODION CARRIED.

MOTION WAS MADE MADE BY DAVIES AND SECONDED BY WADE TO PERMIT RAINBOW GIRLS TO SET UP A FIRECRACKER STAND AT THE OLD HUT CAFE ON WEST SEVENTH STREET. MOTION CARRIED.
