MINUTES OF GALENA CITY COUNCIL MEETING JUNE 16, 1987

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order Tuesday, June 16, 1987 at 7:00 P.M. in the Council Chambers with Mayor Thomas Allen presiding.

ROLL CALL:

Roll call indicated the following councilmembers present: Murray, King, Watkins, Wilson, Fitzer, Anderson, Hayes, Stephenson, Byrd, and Poelma. Absent: None.

MINUTES:

Moved by Anderson, seconded by Watkins, to approve the minutes of the Regular Meeting of June 2, 1987 after making an amendment to Page Three Paragraph 3 to read Dumptruck purchased from C & S Equipment in Picher. Motion declared carried. 1 abstain - Hayes.

PLANNING & ZONING:

Moved by Byrd, seconded by King to accept and place on file the Minutes of the Planning & Zoning Commission meeting of Tuesday, June 2, 1987. Motion declared carried. 1 nay - Poelma.

ITEMS FOR COUNCIL ACTION:

Moved by Watkins, seconded by Anderson to approve the Planning & Zoning recommendation to allow a home occupation license for Frank Seely & Ira Perry for a sharpening service at 602 N. Forest. Motion declared carried. 3 nays - Fitzer, Wilson, Poelma.

Moved by Anderson, seconded by Byrd to approve the Planning & Zoning recommendation to allow a home occupation for Carolyn Watkins for a beauty shop at Rt. 2 Box 286 B. Motion declared carried. 1-nay - Poelma, 1 abstain - Watkins.

PUBLIC HEARING:

A Public hearing was held concerning the application from the City to K.D.O.C. for an Economic Development Grant for Wadler Manufacturing.

Jerry Wade was present from Wadler Manufacturing to state he had been in Topeka and was told what the previous applications had lacked and there was a need for security to be included in this application. Wadlers is acquiring the Galena Precision building and was willing to allow the City to take a second mortgage on that building as security for this loan, which would strengthen the application some, and with other information included, the application would likely be approved.

No further discussion was held on the grant application, so the Mayor declared the public hearing closed.

Moved by Watkins, seconded by Stephenson, that Garry Abram be allowed to work an Auxiliary on Fridays with pay. Motion declared carried. 1 nay - King.

VACATIONS:

Moved by Watkins, seconded by Hayes to approve 2 weeks vacation for Jimmie Robinson from June 30 to July 13. Motion declared carried.

Moved by Anderson, seconded by Hayes to allow one weeks vacation for Gerald Hentz August 13 to August 19. Motion declared carried.

Moved by Murray, seconded by Stephenson to table Robert Helveys request for a vacation July 20-August 3 until next regular meeting. Motion declared carried.

CRIME LAB CONTRACT:

Moved by Watkins, seconded by Anderson, to enter into a contract with MSSC Crime Lab for Police Dept. Laboratory reports for \$2100. Motion declared carried.
