

MINUTES OF COUNCIL MEETING JUNE 17, 1975.

MAYOR JACK MURRAY PRESIDING, COUNCIL MET IN REGULAR SESSION.

MOTION WAS MADE BY LATURNER AND SECONDED BY AVICOLA THAT MINUTES OF MEETING HELD JUNE 3, 1975 AND SPECIAL MEETING HELD JUNE 10, 1975 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY LATURNER AND SECONDED BY AVICOLA THAT THE RESIGNATION OF AUXILIARY POLICEMAN, WILLIAM LAMB, BE ACCEPTED. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HANSBRAUGH AUTHORIZING PERMISSION TO STEWART STANLEY TO REMOVE A PORTION OF THE CURB AND GUTTER ON 4TH ST. TO MAKE WAY FOR AN ENTRANCE TO A PARKING AREA. MOTION CARRIED.
