

MINUTES OF REGULAR COUNCIL MEETING HELD JUNE 21, 1977.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT:

WARD, REED, BANKSON, DAVIES, MURRAY, HOPKINS, ALLEN, LEONARD, MEANS.

COUNCIL MEMBERS ABSENT:

WADE.

MOTION WAS MADE BY LEONARD AND SECONDED BY WARD THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD JUNE 6 AND SPECIAL COUNCIL MEETING HELD JUNE 7 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MAYOR MURRAY ASKED THE COMMUNITY DEVELOPMENT COMMITTEE TO MEET WITH LLOYD MYERS, CITY BUILDING INSPECTOR TO CONSIDER WORKING FOR COMMUNITY DEVELOPMENT IN ADDITION TO PRESENT WORK ON INSPECTION OF REHABILITATION HOUSES AND BRING TO NEXT COUNCIL MEETING.

MOTION WAS MADE BY HOPKINS AND SECONDED BY DAVIES TO PERMIT PRIVATE SWIMMING PARTIES AT THE CITY SWIMMING POOL AT A COST OF \$10.00 PLUS \$10.00 LIFE GUARD SALARY IF THIS DOES NOT CONFLICT WITH REGULAR POOL HOURS. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY HOPKINS TO PURCHASE SUPPLIES FOR THE WATER DEPARTMENT AT A COST OF \$616.38 TO BE PAID FROM WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY LEONARD AND SECONDED BY HOPKINS TO MAKE PAYMENT OF \$1,051.92 ON SIRENS TO BE PAID FROM WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY HOPKINS TO PURCHASE 5,000-6,000 GALLONS OF ROAD OIL AT A COST OF .33 PER GALLON FROM HYDRO-CARBON SPECIALTIES TO BE PAID FROM SPECIAL HIGHWAY FUND. MOTION CARRIED.

MAYOR MURRAY ASK THE PLANNING AND ZONING COMMISSION TO TAKE ACTION ON MOBILE HOME PERMIT APPLICATIONS SUBMITTED BY KAREN PHELPS, ROGER ASH, CARROLL HASENPLAUGH, CHRIS DE GRAFF, AND EVA EIGHME.

MOTION WAS MADE BY BANKSON AND SECONDED BY LEONARD TO ADOPT THE NEW MOBILE HOME PERMIT APPLICATION PRESENTED TO THE COUNCIL BY THE PLANNING AND ZONING COMMISSION. MOTION CARRIED.

MOTION WAS MADE BY MEANS AND SECONDED BY DAVIES THAT A CHECK BE MADE ON THE WATER AND GAS LINES ON SHORT AND WALL STREET TO CONSIDER LOWERING CROWN IN MIDDLE OF STREET. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY LEONARD TO PURCHASE THREE COPIES OF ZONING REPORTER MONTHLY PLUS THREE BINDERS AT A COST OF \$65.00 PER YEAR TO BE CHARGED TO THE WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY REED TO GRANT TOM BROWN (1) WEEK VACATION AND (2) WEEKS LEAVE OF ABSENCE IN AUGUST. MOTION CARRIED.

MOTION WAS MADE BY LEONARD AND SECONDED BY BANKSON THAT C.D.B.G. ORDINANCE 77-12 IN THE AMOUNT OF \$19,773.20 AND PAYROLL AND APPROPRIATION ORDINANCE 77-13 IN THE AMOUNT OF \$35,087.88 BE APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY MURRAY AND SECONDED BY BANKSON TO PURCHASE MATERIAL FOR SEWER ON 22ND STREET NOT TO EXCEED \$4,000.00 TO BE PAID FROM REVENUE SHARING. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY MURRAY TO WITHDRAW TERMINATION NOTICE OF CONTRACT WITH MILLER HAULING SERVICE. MOTION CARRIED. (1) NAY (1) ABSTAINED

MAYOR MURRAY APPOINTED A COMMITTEE OF MURRAY, BANKSON, AND REED TO MEET WITH CITY ATTORNEY, CITY BANKER AND REPRESENTATIVE OF MILLER HAULING SERVICE FOR POSSIBLE AMENDMENTS TO THE CONTRACT AND OR ORDINANCE AND BRING RECOMMENDATIONS TO THE COUNCIL.

MOTION WAS MADE BY MEANS AND SECONDED BY HOPKINS THAT THE MEETING ADJOURN. MOTION CARRIED.
