MAYOR JACK MURRAY PRESIDING, COUNCIL MET IN REGULAR SESSION.

MOTION WAS MADE BY DAVIES AND SECONDED BY LATURNER THAT THE MINUTES OF MEETING HELD JUNE 17, 1975 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT MARY ANN LITTLE BE GRANTED (1) ONE WEEKS VACATION IN LIEU OF VACATION. MOTION CARRIED.

MOTION WAS MADE BY BARKER AND SECONDED BY AVICOLA THAT WAYNE IPOCK BE GRANTED (2) TWO WEEKS VACATION IN LIEU OF VACATION. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY LATURNER THAT THE SWIMMING POOL BE CLOSED JULY 9-10 WITH ALTERNATE DAYS OF JULY 16-17 FOR THE PURPOSE OF REPAIR WORK ON THE POOL. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY JAY THAT THE RESIGNATION OF AUXILIARY POLICEMAN, HARRY F. BEYER BE ACCEPTED. MOTION CARRIED.

MOTION WAS MADE BY BOGLE AND SECONDED BY LATURNER THAT THE STREET COMMITTEE TAKE A SURVEY ON THE STREETS THAT NEED REPAIR. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY JAY THAT THOMAS BROWN AND MONTY MATTISON BE APPROVED FOR AUXILIARY POLICEMEN. MOTION CARRIED.



MOTION WAS MADE BY DAVIES AND SECONDED BY LATURNER FOR THE CITY'S GENERAL LIABILITY INSURANCE COVERAGE BE INCREASED FROM \$50,000 TO \$300,000 AT AN ADDITIONAL COST OF \$230.00 PER YEAR. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BOGLE THAT THE SIGNS AT 7TH AND MAIN STREET PROHIBITING RIGHT TURN ON RED TRAFFIC SIGNAL BE REMOVED UNTIL THE COUNCIL ADOPTED AN ORDINANCE AND SENT THE ORDINANCE TO THE STATE HIGHWAY COMMISSION FOR CONSIDERATION. MOTION CARRIED.

MOTION WAS MADE BY LATURNER AND SECONDED BY BARKER THAT PAYROLL ORD 75-14 BE APPROVED FOR PAYMENT. MOTION CARRIED.
