MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BANKSON UPON RECOMMENDATIONS OF EDWIN RENSMEYER OF THE DIVISION OF ACCOUNTS AND REPORTS, KANSAS DEPARTMENT OF ADMINISTRATION THAT ALL CITY EMPLOYEES RECEIVE A 5% DECREASE IN WAGES ACROSS THE BOARD. MOTION CARRIED. (MESSER ABSTAINED)
