

MINUTES OF COUNCIL MEETING JULY 15, 1975

MAYOR JACK MURRAY PRESIDING, COUNCIL MET IN REGULAR SESSION.

COUNCILMEN PRESENT:

MOTION WAS MADE BY KAEHLER AND SECONDED BY LA TURNER THAT THE MINUTES OF MEETING HELD JULY 1, 1975 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY LA TURNER AND SECONDED BY BOGLE THAT ENVIRONMENTAL LABORATORIES INC. BE DESIGNATED AS THE CITY'S REPRESENTATIVE FOR A KANSAS WATER POLLUTION CONTROL PERMIT AUTHORIZATION FOR A PERIOD OF ONE YEAR AT A COST OF \$52.00 PER QUARTER. MOTION CARRIED.

MOTION WAS MADE BY BOGLE AND SECONDED BY LA TURNER TO RENEW INSURANCE PREMIUM ON CITY'S CHECK PROTECTOR BY PAYMASTER ASSOCIATES INC. AT THE COST OF \$125.00 FOR A TWO YEAR PERIOD. MOTION CARRIED.

MOTION WAS MADE BY BARKER AND SECONDED BY CHESNUTT FOR THE PURCHASE OF A TORCH, HOSES, GAUGES FOR CITY MAINTENANCE AT A COST OF APPROXIMATELY \$167.00 TO BE TAKEN FROM WATER AND STREET FUNDS. MOTION CARRIED.

MOTION WAS MADE BY BARKER AND SECONDED BY LA TURNER TO INSTALL A 215 FOOT SIDEWALK IN FRONT OF A NEW NURSING HOME BEING CONSTRUCTED BY JOHN LINK, AND DESIGNATED THE TUESTMAN CONSTRUCTION CO. OF JOPLIN TO INSTALL THE WALK AT A COST OF \$900.00. MOTION CARRIED. SIX YEAS AND ONE NAY (KAEHLER).

MOTION WAS MADE BY BOGLE AND SECONDED BY LA TURNER FOR THE PURCHASE OF 20 GALLON OF FLY CONTROL AND 20 GALLON OF VEGATATION CONTROL AT A COST OF \$422.00 TO BE TAKEN FROM THE SEWER FUND. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY DAVIES TO GRANT R. L. CARTER A ONE-ACRE TRACT IN THE CITY'S INDUSTRIAL PARK FOR THE ESTABLISHMENT OF A BURIAL VAULT MANUFACTURING OPERATION, THE TRACT IS TO BE SOUTH OF HUMBLE SANDS CO. MOTION CARRIED.

MOTION WAS MADE BY BARKER AND SECONDED BY HANSBRAUGH THAT W. BURKHART BE GRANTED ONE WEEK VACATION PAY IN LIEU OF VACATION. MOTION CARRIED.

MOTION WAS MADE BY BOGLE AND SECONDED BY LA TURNER THAT PAYROLL AND APPROPRIATION ORD 75 - 15 BE APPROVED FOR PAYMENT. MOTION CARRIED.
