- CALL TO ORDER:** The meeting of the Galena City Commission was called to order on Monday, July 16, 2001, at 6:00 p.m. in the commission chambers with Commissioner Tom Brandenburg presiding.

- Commissioner Oglesby entered chambers at 6:20 p.m.
- MINUTES:** Motion made by Hardman, seconded by Jackson to place on file the minutes of the Galena Fire Dept. meeting, June 28, 2001. Motion declared carried.

20 ACRES:

City Manager, Jack Murray stated he had the property they discussed buying appraised by Neil Hale and it had been appraised \$3,000.00 more than the asking purchase price. He advised the money would have to come from the landfill and transferred to the General fund to purchase the property and they would probably have to change the budget at the end of the year to allocate the purchase.

Moved by Hardman, seconded by Jackson to purchase the 20 acres of land. Motion declared carried.

Code Enforcement Officer Mike Smith updated the commission on the cleanup process in the city. He advised that overall the work was slow, but going well, with cooperation from most of the residents.

LAGOON:

He stated a sign on his store's marquee advising customers to call city hall about the problem was not intended to be a slam against the city. He was also concerned that his store was not receiving grocery orders for the city jail in the last couple of weeks and felt it might be a reprisal for the sign on the marquee.

The commission advised Mr. King to come in and talk with the city manager for a solution to the problem.


ADJOURNMENT:
