MINUTES OF THE GALENA CITY COUNCIL, GALENA, KANSAS, AUGUST 1, 1967

The council met in regular session in the council chamber at the city hall at 7:00 p.m., August 1, 1967.

Present: Councilmen Piercefield, Watkins, Cure, Kitch, Karr, and Pittman.

Absent: None.

Presiding: Mayor Frank P. Dillon.

Invocation: Mayor Dillon.

Following roll call, Councilman Karr moved, seconded by Pittman, that the reading of the minutes of July 19, 1967, be dispensed with and that same be approved as shown. Motion carried viva voce.

Mayor Dillon presented Bob Scott, Commander of the American Legion's Parks-Wade Post No. 246 Inc., who in turn presented the Mayor with a contribution of \$100.00 to the Galena Cemetery Association.

Councilman Piercefield moved, seconded by Councilman Watkins, that the parking lines on the east side of Main between Sixth and Seventh Street be changed to such an angle whereby the driver pulling out from the curb would be able to see easily oncoming traffic on a trial basis in an effort to assist in the elimination of traffic accidents. Motion carried on a show of hands.

Councilman Piercefield moved, seconded by Watkins, that the City Marshall's report as read by him for the month of July, 1967, be accepted and placed on file within the City Clerk's Office. Motion carried on roll call vote as follows: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - None.

Councilman Barker moved, seconded by Pittman, that six (6) new water meters be purchased for the Water Department. Motion carried on roll call vote: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, Pittman. Nays - None. Passage of the motion was declared by Mayor Dillon.

Councilman Pittman moved, seconded by Councilman Karr, that two (2) loads of road oil (MC-3 46-20) be purchased for use within the Street Department. Motion carried on roll call vote as follows: Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - None.

Following a lengthy discussion, Attorney Yount advised the Council that property owners were responsible for dead trees on parkways, whereas, the City was responsible for the removal of dead trees on property owned by the City.

Councilman Watkins introduced the following resolution:

Councilman Watkins moved, seconded by Piercefield, that the foregoing resolution be adopted by roll call vote. On roll call the vote was: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman.

Councilman Watkins moved, seconded by Piercefield, that the Street Committee handle the matter of investigating and establishing the costs involved for a citizen to secure a permit to build a driveway at their home.

On roll call the vote was: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - None. Passage of the motion was declared by Mayor Dillon.

Councilman Watkins moved, seconded by Councilman Karr, that the City Attorney draw up an ordinance for the costs of a building permit of \$1.00. Motion passed viva voce.

City Marshall Hamlin informed the Governing Body that the traffic lights in Joplin, Missouri, were maintained by The Empire District Electric Company.

Councilman Karr moved, seconded by Cure, that the swimming pool be drained, cleaned, and placed back in operation as soon as possible. Motion carried on roll call vote as follows: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - None.

Councilman Karr moved, seconded by Councilman Pittman, that the exit on Main Street at Thirteenth and Elm be repaired, also, a dead tree to be removed in the swimming pool area; the alley behind the Sixth Street Baptist Church to be repaired by the Street Department. Motion carried viva voce.

Councilman Karr moved, seconded by Pittman, that 200 ft. of 1" pipe, 1,000 ft. of 3/4" pipe, of plastic line, not to exceed the cost of \$130 be purchased for use in the Oak Hill Cemetery area. Motion carried on roll call vote as follows: Yeas - Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - Piercefield.

Councilman Pittman moved, seconded by Councilman Cure, that authority be granted Mr. Jerry Wade to cut down and grade the street between Twelfth and Eleventh on Yale Avenue. Motion carried on roll call vote as follows: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman.

Mayor Dillon read at length a letter from Travis Miller, Assistant Regional Administrator for Metropolitan Development denying admission of the application filed by the City for a sewer grant under the Basic Water and Sewer Facilities Grant Program.

Councilman Piercefield read a communication to the City Marshall from the State Highway Department advising the type of safety helemets to be used by motorcyclists.

Councilman Piercefield introduced an ordinance relating to the landfill and city dump of the city of Galena, Kansas: requiring fee and permit from users thereof from without the State of Kansas: prohibiting removal of trash, rubbish, salvage material or any other article or material therefrom without the consent of the operator of the city landfill and providing penalties for the violation of said ordinance.

Following discussion of the ordinance, Councilman Piercefield moved, seconded by Watkins, that the foregoing ordinance be adopted by roll call vote. On roll call the vote was as follows: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. The title was agreed to and the ordinance was numbered <u>841</u>.

Councilman Watkins introduced Ordinance No. 530, an ordinance for making payment of certain claims; the meeting being public the ordinance was discussed and amended. On third and final reading, the ordinance was approved by roll call vote as follows: Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - None.

Councilman Pittman presented an application by William F. Nelson to operate a taxi within the city. Councilman Pittman moved that the application be approved; motion seconded by Councilman Piercefield. Motion carried on roll call vote as follows: Yeas - Piercefield, Watkins, Barker, Cure, Kitch, Karr, and Pittman. Nays - None. Passage of the motion was declared by Mayor Dillon.

Councilman Pittman moved, seconded by Karr, that the property owner, Mr. Pickett, at Thirteenth and Chicago be advised by the city clerk that weeds at that location were considered a nuisance and complaint had been received by the City; that after five days of notice if the owner should refuse, the street commissioner would cut or destroy such weeds and the cost of same be assessed against the property.

Councilman Piercefield moved, seconded by Councilman Cure, the meeting adjourn. Motion carried by a show of hands.
