MINUTES OF REGULAR MEETING GALENA, KANSAS HELD AUG 3, 1971

Council met in regular session with Mayor Murray presiding.

Councilmen present were ANDERSON, BANKSON, BAILEY, BROWN, CANTRELL, COBLE, HANSBRAUGH, KAEHLER, WASHOM AND WILLIAMS.

Minutes of regular meeting of July 20th, was presented to the council. The City Attorney gave his opinion of the minutes, and his legal advise. Motion by Cl. Anderson and second by Cl. Hansbraugh that the minutes be approved as presented. Upon a Roll call vote the Yea' Anderson, Bailey, Cantrell, Hansbraugh, & Washom. Nea' Brown, Coble, & Kaehler Obstaining were Bankson, & Williams. The minutes were approved.

Mrs. Calvin Baker Jr. was present at the meeting, requesting permission to hook up on the water line on east 22nd St. Motion by Cl. Bailey and seconded by Cl. Washom, this be tabled for later action. Motion carried.

Terry Ward attended the meeting and explained about the lift station on west llth St. The station had been broken down, and flooded the electrical parts, which he replaced. Mr. Ward advised the council that a maintance man look about these station everyday. Motion by Cl. Cantrell and seconded by Cl. Coble, that Mr. Marvin Goff look at the stations everyday and report to council at the next meeting as to whom, he thought should check the stations in the future. Motion carried.

A letter from C. B. Simons (the engineering firm doing the city's sewer work), was read to the council. The letter requested that the City write a letter to his local banker, stating that his company would have monies due them when the sewer phase #3 was started. Motion by Cl. Cantrell and seconded by Cl. Bailey, that the Mayor sign and return the letter to Mr. Simons. Motion carried.

Application for a cereal malt beverage license under the name of Velma Miller was read to the council. It was pointed out according to city ord. that the license could not be issued, as Mrs. Miller is not a resident of Galena.

Mayor Murray, presented the name of Bill Lyerla as a aux. policman. Motion by Cl. Hansbraugh and seconded by Cl. Anderson the appointment be comfirmed. Upon a roll call vote. The following answered Yea! Anderson, Bailey, Bankson, Cantrell, Hansbraugh, and Washom. Nea! Brown, Coble, Kaehler, and Williams. Mr. Lyerla was confirmed.

Motion by Cl. Brown and seconded by Cl. Washom, the clerk notify all persons doing business in Galena, that occupation license for the last half of the year is past due. Motion carried.

Motion by Cl. Bailey and seconded by Cl. Coble that Rudalph Procino's water bill for \$8.69 be adjusted to a six months average. Upon a roll call vote the following answered Yea' Anderson, Bailey, Bankson, Cantrell, Coble, Hansbraugh, Kaehler, & Washom. Nea' votes were Brown, and Williams. Motion carried.

Trailer permit by Marie Hardwick to park a mobile home at 17th & Main was read to the council. Motion by Cl. Kkehler and seconded by Cl. Williams that permission be denied as the area was not zoned for mobile homes. Motion carried.

Motion by Cl. Washom and seconded by Cl. Cantrell, that the contractors building the units for the Housing Authority, must buy a building permit. Motion carried.

Motion by Cl. Kaehler and seconded by Cl. Williams that bids be taken for a tractor 35-40 horse power with a power take off. Motion carried.

Motion by Cl. Bailey and seconded by Cl. Williams, that a notice be placed in the local paper that a city mechanic was needed. Motion carried.

Mayor Murray appointed Cl. Cantrell, to check on ord. pertaining to trash burning, etc.

Motion by Cl. Williams to purchase a pontiac from Pruitt Mtr. Co. to be used as a police car, with the price difference between the 70 Ply. being \$2,370.00. Second was made by Cl. Bankson Upon a roll call vote the following Answered Yea' Anderson, Bailey Bankson, Brown, Cantrell, Coble, Hansbraugh, Kaehler, Washom, and Williams. Nea' none Motion carried.

Motion by Cl. Williams and seconded by Cl. Washom, that police chief, obtain a price list on blue police uniforms, from uniform companies. Motion carried.

Motion by Cl. Williams, that the policemen be paid an extra days pay per week since one patrolman is in the hospital, and each man is working six days per week. Cl. Bankson seconded the motion. Upon a roll call vote the following answered Yea' Anderson, Bankson, Kaehler, Williams; Nea' votes Bailey, Brown, Coble, Hansbraugh, and Washom. Obstaining, was Cantrell. Motion did not carry.

The monthly reports of the City Police Judge and the City Marshal was read by the clerk. Fines for the month of July 1971 collected by the Judge was \$1,039.00 and the fees paid the Marshal was \$18.00. Motion by Cl. Hansbraugh and seconded by Cl. Anderson the reports be accepted and placed on file. Motion carried.

Ord. #655 allowing claims against the city in the amount of \$8,674.26 was presented to the council. Motion by Cl. Williams and seconded by Cl. Hansbraugh, the ord. be adopted for payment. Motion carried.

Motion by Cl. Brown and seconded by Cl. Washom the meeting adjourn. Motion carried by standing.
