

MINUTES OF THE MEETING OF THE CITY COUNCIL, GALENA, KANSAS AUGUST 17th, 1971

COUNCIL MET IN REGULAR SESSION WITH MAYOR MURRAY PRESIDING

COUNCILMEN PRESENT: ANDERSON, BANKSON, BAILEY, BROWN, CANTRELL, HANSBRAUGH, KAEHLER WASHOM, AND WILLIAMS.

Minutes of the regular meeting of Aug. 3rd was presented to council. Motion by Cl. Anderson and seconded by Cl. Bankson, the minutes be accepted as presented. Motion carried.

PRIDE representatives Mr. McCartney and Mr. McAfee attended the meeting and discussed the city's planning and development program.

Wilbur Moodey attended the meeting, and ask council if a 4 inch water main could be installed in the Hillview Addation. Motion by Cl. Hansbraugh and seconded by Cl. Bankson, that the committe investigate and report back at the next meeting. motion carried.

Mayor Murray appointed the following to serve on the Galena Public Library Board. Fred Braun, John Simon, Edythe Abbey, and Dortha Senter. Motion by Cl. Anderson and seconded by Cl. Hansbraugh that the appointments be confirmed. Upon a Roll Call vote the following answered Yea! ANDERSON, BANKSON, BAILEY, BROWN, CANTRELL, HANSBRAUGH, KAEHLER, WASHOM, AND WILLIAMS. MOTIONCARRIED.

Mayor Murray ask the council to approve the employment of Lloyc Burrows, and Jerry Peters, as city employees. Upon a rollcall vote the following answered Yea! ANDERSON, BANKSON, BAILEY, CANTRELL, HANSBRAUGH, KAEHLER, WASHOM, WILLIAMS. NEA? VOTE by Cl. BROWN. MOTION CARRIED.

Motion by Cl. Bailey and seconded by Cl. Hansbrqugh that the city Attorney, check into the reason why the Industrial area owned by the city on north main was on the tax roll for sale. Motion carried.

Mayor Murray informed the council about the trip to Kansas City pertaining to the Urban Renewal Loan, grant. The regularCity Council Will be the Urban Renewal Authority according to the K.C. office.

Motion by Cl. Bailey and seconded by Cl. Bankson, that an add be placed in the local paper, to take applications for a secretary to work in the city office, pertaining to the Urban Renewal. upon a roll call vote, all present answered Yea' Motion carried

Bids for a tractor was presented to the council. Motion by Cl. Williams and seconded by Cl. Bailey that the purchase be made from Chapman & Follmer, with a trade differance of \$3,691.41. Upon a rollcall vote the following answered Yea' ANDERSON, BANKSON, BAILEY, BROWN, CANTRELL, HANSBRAUGH, KAEHLER, WASHOM, WILLIAMS. Nea' NONE. Motion carried.

Permission was granted to the VFW, to hold a turkey shoot under the supervision of the city marshal.

Motion by Cl. Washom and seconded by Cl. Cantrell that Calvin Baker Jr. be allowed water hook up on east 22nd St. after, deposit is made with city clerk. Upon roll call vote the following answered Yea' ANDERSON, BANKSON, BAILEY, BROWN, CANTRELL, HANSBRAUGH, WASHOM, & WILLIAMS. Nea' vote Kaehler. Motion carried.

Motion by Cl. Kaehler and seconded by Cl. Washom, the FHA be notified to hold up the payments on houses on E. 22nd St. untill all hook up fees are paid. Motion carried.

Motion by Cl. Kaehler and seconded by Cl. Washom the water bills be adjusted to a six months average on the following. Natha Anderson, Hal Leonard, and Don Youngblood. Motion carried.

Marvin Goff was ask to work with the meter reader and report at the next meeting. Motion by Cl. Kaehler and seconded by Cl. Washom that the street dept. cut the weeds near the rodeo grounds. Motion carried.

Motion by Cl. KAEHLER AND SECONDED BY CL. BANKSON, that comunity action group be allowed the use of city hall for a meeting Sept. 9th, at 7:30 PM. Motion carried.

Motion by Cl. Kaehler and seconded by Cl. Bailey that the city Marshal make a list of buildings, that look bad, and have the building inspector look about it and report to council. Motion carried.

Motion by Cl. Williams and seconded by Cl. Kaehler, the park committee be authorized to tear down the old barn and use the lumber at the park, also to spend up to \$900.00 on tables, snack shack, routing stream, and fix up the area for over night camping. Motion carried.

Motion by Cl. Bankson and seconded by Cl. Kaehler that Bob Turner and Lester Adams be allowed 2 weeks pay in lieu vacation. Motion carried.

Motion by Cl Bankson and seconded by Cl. Williams that the police committee accept bids on tires for the Chev. police car. and buy the best bid. Motion carried.

Motion by Cl. Williams and seconded by Cl. Bailey the meeting adjourn. Motion carried by standing.
