MOTION WAS MADE BY KAEHLER AND SECONDED BY BANKSON TO REPAIR 11TH STREET FROM MAIN TO EUCLID AND 12TH STREET FROM EUCLID TO STATE LINE. MOTION FAILED.

MOTION WAS MADE BY BOGLE AND SECONDED BY DAVIES THAT STREET COMMITTEE GET TO-GETHER AND DETERMINE PRIORITY ON STREET REPAIRS. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY AVICOLA UPON RECEIPT OF A LETTER FROM WILEY BURKHART THAT HE WOULD NOT PICK UP THE OPTION ON LAND PURCHASED BY HIM FROM THE CITY. IT WOULD BE TRANSFERRED TO R. L. CARTER. MOTION CARRIED.

MOTION WAS MADE BY JAY AND SECONDED BY BANKSON THAT MARY ANN LITTLE REMAIN IN THE GROUP INSURANCE PLAN AND PAY HER OWN PREMIUMS WHICH WAS INCLUDED IN HER \$725.00 A MONTH SALARY. MOTION CARRIED WITH (2) NAYS: HANSBRAUGH AND AVICOLA.
