PLAQUE:	The commission presented to Interim City Manager, Jack Murray a plaque in appreciation for his commitment to the city of Galena.
RECEPTION:	Moved by LaTurner, seconded by Coleman to retire to the Community Room for a reception, held by the Chamber of Commerce for the new City Manager. Motion declared carried.
