

MINUTES OF COUNCIL MEETING HELD SEPTEMBER 16, 1975.

MAYOR JACK MURRAY PRESIDING, COUNCIL MET IN REGULAR SESSION.

COUNCILMEN PRESENT:

MOTION WAS MADE BY BANKSON AND SECONDED BY DAVIES THAT THE MINUTES OF COUNCIL MEETING HELD SEPTEMBER 2, 1975 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY JAY AND SECONDED BY DAVIES THAT ALL H.U.D. APPROPRIATIONS BE PRESENTED TO THE COUNCIL WITH THE CHECK NUMBER AND AMOUNT OF CHECK FOR APPROVAL BEFORE PAYMENT IS MADE. THE APPROPRIATION IS TO BE PRESENTED ONCE A MONTH ALONG WITH THE CITY'S APPROPRIATIONS. MOTION CARRIED.

APPLICATION FROM THE PLANNING AND ZONING COMMITTEE FOR A MOBILE HOME PERMIT WAS READ FOR JOHNNY LINK ON NORTH COLUMBUS IN EMPIRE. MOTION WAS MADE BY BOGLE AND SECONDED BY BANKSON THAT THE PERMIT BE GRANTED. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY DAVIES THAT ORDINANCE 18-416 BE CHANGED TO READ NOT LESS THAT \$300.00 OR MORE THAN \$1,000.00 OR 30 DAYS TO ONE YEAR IN JAIL AND/OR BOTH FOR ASSULTING POLICE OFFICERS, CITY ATTORNEY, JUDGE OR MATRON. MOTION CARRIED.

MOTION WAS MADE BY JAY AND SECONDED BY HANSBRAUGH TO HOLD CHECK #256 OF THE APPROPRIATION AND CHECK TO SEE IF IT IS TO BE PAID FROM H.U.D. GRANT. MOTION CARRIED.

MOTION WAS MADE BY KAEHLER AND SECONDED BY BOGLE TO DELETE CHECK #2227 TO HAL BRENEMAN ON APPROPRIATION ORDINANCE FOR VERIFICATION UNTIL THE NEXT APPROPRIATIONS. MOTION CARRIED.

MOTION WAS MADE BY KAEHLER AND SECONDED BY BOGLE THAT PAYROLL AND APPROPRIATION ORDINANCE 75-20 BE APPROVED AS AMENDED. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY DAVIES TO TRANSFER \$5,515.77 FROM REVENUE SHARING TO THE GENERAL ACCOUNT. MOTION CARRIED.

MOTION WAS MADE BY BARKER AND SECONDED BY BOGLE THAT MARY ANN LITTLE HAVE INSURANCE PAID FROM H.U.D. GRANT FUNDS. MOTION CARRIED.


