MINUTES:	Moved by Rogers, seconded by Ward to approve and place on file the Minutes of the Regular City Council Meeting of September 3, 1996. 1-ABSTAIN: ADAMS. Motion declared carried.
	Moved by Rogers, seconded by Ward to place on file the minutes of the Galena Firemens Relief Association meeting of September 12, 1996. Motion declared carried.
MOBILE HOME APPLICATION:	Moved by Ward, seconded by Rogers to approve Mobile Home application fof Jay Youngblood at 1300 N. Forest since there were no objections. Motion declared carried.
BIDS FOR DIRT:	Tom Allen advised the Council of the need for dirt at the Old Galena Cemetery. Bids from Joe Gourley for \$35.00 per load and from Sonny Webster for \$38.00 per load were received from Tom Wade.

	Mayor Oglesby presented William Wilson as Patrolman. Moved by Shryock, seconded by Reynolds to approve William Wilson as Patrolman. Motion declared carried.
	Bob Shryock advised he had sat in on a Personnel Committee Meeting for Mr. Reynolds to review application for City Superintendent and req approval of Mel Mittag as City Superintendent.
	Doris Adams requested an opinion from the City Attorney on whether or not
