

MINUTES OF REGULAR COUNCIL MEETING HELD SEPTEMBER 19, 1978.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT:

MOTION WAS MADE BY HOPKINS AND SECONDED BY WADE THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD SEPTEMBER 5, 1978, BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY BANKSON THAT THE PETITION PROTESTING AN ORDINANCE TO BAN ALL ANIMALS FROM CITY PARKS BE ACCEPTED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE THAT PERMISSION BE GIVEN TO THE COUNTY NURSE TO USE THE COMMUNITY ROOM THE FIRST THURSDAY OF EVERY MONTH FROM 1:00 P.M. TO 3:00 P.M. FOR BLOOD PRESSURE CHECKS. MOTION CARRIED.
