WATER LINE TO INDUSTRIAL TRACT: The Regular Meeting of the City Council of the City of Galena was called to order by Mayor James Bankson, at 7:00 P.M., in the Council Chambers on Tuesday, September 20, 1983.

Roll call indicated the following councilmembers present: Gibson, King, Hayes, Means, Little, Anderson, J. Watkins, Colgrove, R. Watkins, Allen. Absent: none

Moved by J. Watkins, seconded by R. Watkins, to approve and place on file the minutes of the Regular Meeting on September 6, 1983. Motion declared carried.

Moved by J. Watkins, seconded by R. Watkins, to place on file the minutes of the Regular Meeting on September 12, 1983 of the Planning & Zoning. Motion declared carried

Marvin Kaehler appeared before the council asking why his pond had been declared a nuisance. City attorney presented Mr. Kaehler with a copy of the written report by the building inspector, which stated that the health department has notifed Mr. Porter about the pond. It was suggested that the pond be rerouted to the south or southwest to eliminate the problem.

Moved by J. Watkins, seconded by Gibson, to give Mr. Kaehler 30 days to abate the nuisance . Motion declared carried. (3 nays- R. Watkins, Means, Anderson)

Moved by R. Watkins, seconded by Little, for the city to buy 2 yards of concrete to be used on the new piece of land given to Mr. Zimmerman. Motion declared carried. (1-nay- Hayes)

Several local tavern and retail business owners appeared before the council again to express their protest concerning the Charter Ord. #5 which would increase cereal malt beverage license fees.

Moved by J. Watkins, seconded by Little, to approve a Charter Ordinance to repeal Charter Ordinance #5. Vote to be by roll call. Roll Call vote indicated: 5-nays - Hayes, Means, Anderson, Colgrove, Allen 4-yeas- Gibson, Little, J. Watkins, R. Watkins 1-abstention- King Motion declared failed.

Moved by Colgrove, seconded by Little, to send a letter to Helen Masher and Helen Yount owners of 1019 Wall stating that no further extensions would be granted on the condemned property and that the City would remove the structure as soon as the bulldozer could be brought to town. Motion declared carried.

Cable T. V. contacted the City and ask if the City would collect their cable fees from customers and they in turn would pay for salaries involved in the collection. The council discussed the request but decided against it since it was a private business.

Moved by Little, seconded by R. Watkins, to allow the installing of approximately 1000 feet of water line, to run from the Zimmerman property and would loop the dead in line and correct a problem there at an approximate cost of \$420. Motion declared carried. Page Two

Bids from six (6) companies were read by the Chief of Police concerning winter uniforms.

Moved by Little, seconded by Anderson, to purchase a complete uniform consisting of 2 shirts, 2 pants, 1 coat, 1 hat, and 1 tie, for each of the 6 regular patrolman at a cost of \$207.85 each. Motion declared carried.

Moved by Little, seconded by R. Watkins, to purchase 6 badge emblems from Jay Uniforms for \$1.99 each. Motion declared carried.

Moved by R. Watkins, seconded by Gibson, to approve a program that would establish an Alcohol & Drug abuse program in the Public Schools. Motion declared carried.

Mayor Bankson informed the council of the cost of tires for the trash truck. There has been an excess of flats and extra cost due to using the alleys instead of the streets to pick up trash. Mayor Bankson referred thematter to the sanitation committee to look into and present some information for the next meeting.

Moved by R. Watkins, seconded by Little, to purchase from the lowest bidder, Joplin Supply, 2 dual base wall heaters with 60,000 BTU at at cost of \$366.58 each and 1 single base wall heater at a cost of \$338.80. Motion declared carried.

Moved by Little, seconded by R. Watkins, to place on file the stockmarshalls report for Aug. 13 to Sept. 15. Motion declared carried.

Moved by Little, seconded by J. Watkins, to allow the Chief of Police Lyerla time off in order to attend a civil defense meeting in Wichita for the county. The county will pay his expenses. Motion declared carried.

Finance Committee will meet Monday night at 6:00 p.m. Sanitation Committee will meet Tuesday night at 6:00 p.m.

Moved by Little, seconded by Colgrove, to approve HUD Appropriations 83-3 in the amount of \$100.00. Motion declared carried.

Moved by J. Watkins, seconded by Gibson, to approve payroll 83-21 in the amount of \$13,398.03. Motion declared carried.

Moved by J. Watkins, seconded by R. Watkins, to approve Appropriations 83-21 and 83-21a in the amount of \$60,475.91 and \$1240.14. Motion declared carried. (void ck. # 8173 to state for flag) Mayor Bankson thanked the DAV for donating a State and U.S. Flag to the City to be used on our flag pole.

Moved by R. Watkins, seconded by Little, that the regular meeting of the city council be adjourned. Motion declared carried.
