

MINUTES OF MEETING HELD SEPTEMBER 21, 1976.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT:

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE MINUTES OF COUNCIL MEETING HELD SEPTEMBER 7, BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE COUNCIL WITH AN APPLICATION FOR A CEREAL MALT BEVERAGE LICENSE FOR LEOTA CURE TO BE USED AT THE F & R PIT B-B-Q, 210 W. 7TH STREET.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY AVICOLA THAT THE LICENSE BE GRANTED. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE CITY ATTORNEY DRAW UP A ORDINANCE FOR A 1/2 CENT CITY SALES TAX EFFECTIVE JANUARY 1, 1977. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY LEONARD TO INSTALL STOP SIGNS ON THE EAST AND WEST SIDE OF GALENA AVENUE AT 17TH STREET. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA TO EXTEND YELLOW PARKING LINE BY AMERICAN LEGION TO (2) CAR LENGTHS. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HANSBRAUGH TO BLOCK MAIN STREET FROM 4TH TO 7TH FOR MINER'S DAY SEPTEMBER 25 UNTIL 11:00 P.M. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HANSBRAUGH TO APPROVE C.D.B.G. ORDINANCE 76-18 IN THE AMOUNT OF \$122,888.16 FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA TO APPROVE PAYROLL AND APPROPRIATION ORDINANCE 76-21 AND BOND & INTEREST AS FOLLOWS PAYROLL - \$4,147.04 APPROPRIATION - \$33,292.48 BOND & INTEREST \$38,743.81 FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY LEONARD AND SECONDED BY AVICOLA THAT FLOYD BURROWS OF 1806 JOPLIN STREET BE DISALLOWED TO PARK HIS TRUCK AT HIS RESIDENCE AT THIS TIME. MOTION CARRIED.

MAYOR MURRAY APPOINTED A CITIZEN COMMITTEE OF SAM LANDIS, CHARLES HAMPSON, JOHN CURE, AND HOWARD JARVIS TO WORK WITH STREET COMMITTEE ON A SURVEY OF THE STREETS TO DETERMINE THE LOAD LIMITS.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT THE MEETING RECESS FOR 15 MINUTES. MOTION CARRIED.

THE MEETING RECONVENED AT 9:50 P.M.

MOTION WAS MADE BY AVICOLA AND SECONDED BY LEONARD THAT A FEE OF \$50.00 PER YEAR BE SET FOR OCCUPATIONAL LICENSE FOR PICK UP SERVICE OF SOLID WASTE. MOTION CARRIED.

EDWIN A. RENSMEYER FROM DIVISION OF ACCOUNTS AND REPORTS DEPARTMENT OF ADMINISTRATION, TOPEKA WAS PRESENT FOR A DISCUSSION ON THE 1977 BUDGET FOR THE CITY.

MOTION WAS MADE BY LEONARD AND SECONDED BY BANKSON THAT THE CITY ADOPT A 1977 BUDGET ON A 40 MILL TAX LEVY. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT THE MEETING ADJOURN UNTIL 7:00 P.M. SEPTEMBER 28. MOTION CARRIED.
