The commission stated they would have to take this under future consideration.

GIRL'S SOFTBALL ASSOC:

Dennis Garner approached the commission on red clay which the city had agreed to purchase, but stated all of it had not been delivered to the softball field. He also stated the need for help with the mowing and lights put up. The commission stated they would help as much as possible and to contact Supt. Mittag about delivery of clay and the lights.


ANNEXATION CONTRACT &


September 21, 1998
