Mayor Donaldson introduced Ken Horn as the city's new Police Chief.

RT-66 BRICKS:

Commissioner Shoemaker stated after considering Mr. Nolan's proposal of testing bricks taken from Main Street-Rt 66 for sale on E-Bay he would like to give an additional proposal to use some of the bricks on the reconstruction of Main Street, suggesting bordering the crosswalk with bricks, boxing around the new period lighting. He asked for a small preservation group be appointed by the commission with Jim Ray and Paul Nolan cochairmen of the group.

Moved by Davies, seconded by Shoemaker to create a brick preservation committee to oversee the use and the sale of the bricks on E-bay. **Motion** declared carried.

City Supertendent, Mel Mittag advised the commission had information in their packets, in which the state was giving them until June 15th to have the utilities relocated or have plans to remove them. He said he has been working with the engineer to accomplish this.

City Supertendent, Mel Mittag approached the commission on the city making their own signs. He stated he had retirees who would like to volunteer their time.

The commission requested a proposal be brought back to them on cost of equipment and material.

PROPOSED NEW HOUSING SUB-DIVISION:

City Manager, Jim Ray presented to the commission a proposed housing sub-division on 21 acres of city property on 21st Street, which is not being used. It would provide sixty-three (63) lots and housing would range from \$65,000.00 to 90,000.00.

Lots would be sold at \$5,000.00 per lot up front; city would put in streets, water and sewer, at an estimated cost of \$3,200.00 per house, which would be reimbursed when contractor sold the house. He advised it was not going to happen tomorrow it would take four (4) to six (6) months to get started.

ENGINE REPAIR PATROL CAR:

City Manager, Jim Ray stated bids to put the engine in, County was going to give them was \$800.00 to \$1,200.00.

Commissioner Davies stated the people should know what happen to the vehicle. They just flat didn't check the oil in the car and burnt the engine up.

Jim Ray advised this happen right after he took the city manager position and new Chief Horn has put a daily check system in place.

APPROPRIATION 05-01:

Commissioner Davies questioned the computer for \$1036.00 for the Police Dept. since they had recently purchased three for the department and stating purchasing over \$300.00 is suppose to be approved by the commission. He felt they need to stick to the \$300.00, hiring freeze, salary freeze and not encumber the new council before they get in.
