Councilmember Bankson said after the work sessions and get language in order that the official bidding process can start and have the individuals re-submit bids.

City Superintendent Richey told the council of some local cemeteries that used weed killer around the headstones and that it looked nice. Mayor Oglesby said he knew of a place that would give the city a 55-gallon drum of weed killer for free if the city would go to Ft. Scott to pick it up.
