The fire department had met and agreed to pay for carpet and he told them he would present to the commission for consideration sometime after November when they see how the budget stands. He advised Fire Chief, Bill Hall suggested Jeremy go to Derailed Commodity for carpet pricing, and advised we may be looking at reimbursing the fire department when we see how we stand on the budget.

VOGELL PROPERTY 5<sup>th</sup> & BELLEVUE:

City Manager, Jack Murray stated that a register letter was sent on this property which gave him 10 days to repair or be demolished. City Manager said some questions where raised and decided he would put it before the commission.

He stated the city attorney advised there could be some concern if the city went in and took it down. The city attorney stated that what he did not see was the proper owner being sent papers and signing for them.

Mr. Vogel stated he would get with his sisters, and get back with the city manager to see if they wanted to commit to fixing the property up.
